There's an old saying about a proverbial thousand-pound gorilla in the room that no one is talking about. But recently, Donor-Advised Funds have become the thousand-pound gorilla that everyone is talking about.

Donor-Advised Funds can be summarized with three simple words - give, grow, grant. That's how easy it can be for an individual or family to fulfill their charitable wishes through a Donor-Advised Fund.

This type of charitable fund is an attractive alternative to creating a family foundation. Gifts to a donoradvised fund are tax-deductible according to your circumstances. The Independent Catholic Foundation grows the fund with Catholic investment screenings - unlike other foundations or investment agencies, and we permit annual donor-suggested grants to Catholic causes within the Diocese of Altoona-Johnstown. funds. Permanent Endowments preserve the principal investment (which includes all contributions) releasing an annual percentage of earnings approved by our Board of Trustees to beneficiaries suggested by the donor. Provisional, or Temporary, Endowments permit an annual distribution up to 50% of the principal investment. Foundation guidelines are in place minimum annual grant amounts and timing.

If you already have a Donor-Advised Fund, you can also use it to create a family endowment to support your most cherished Catholic causes. Scholarship Applications Available for Blair County Junior and Senior College Students

Applications are now being accepted for the 2018 Welge Scholarship which assists Blair County students who are entering their junior or senior year (third or fourth year) at an accredited college or university. The Welge Scholarship was established in 1995 to honor Adelaide G. (Heverly) Welge who was a firm believer in higher education.



This summer, the Foundation intends to award three \$500 scholarships. Applicants with demonstrated financial need must be members in good standing at a Roman Catholic Parish in Blair County excluding Saint Matthew Parish in Tyrone which has its own scholarship program.

Announcing Three New Endowments for Immaculate Conception Parish in Dudley, Huntingdon County

Immaculate Conception Parish, under the direction of administrator Father Matthew Baum, along with the finance council, parish council and cemetery committee, has established three new permanent endowments with the Independent Catholic Foundation designated for the long-term benefit of Catholic needs in Dudley, Huntingdon County.

Father Matthew presented a vision for the long-term benefit of the parish, cemetery and parish grotto with an announcement last fall on Stewardship Sunday. After Mass that same weekend, Bill Hiergeist and Chris Ringkamp explained the governance structure of the Independent Catholic Foundation



to the councils and committee, and reviewed how it invests endowments using Catholic socially-responsible guidelines.

The Immaculate Conception Parish Endowment will generate annual




distributions for important needs as determined by the pastor and finance council. The Ave Maria Cemetery Endowment will produce funds annually for its Perpetual Care needs. The Mary's Meadow and Grotto Endowment will offset annual maintenance and electrical expenses for the

beautiful grounds adjacent to the rectory that were built through a generous bequest from parishioner Mary Maffucci.

Immaculate Conception Parish welcomes memorial gifts to the Parish Endowment as well as charitable gifts through one's Last Will. As the Parish Endowment grows, the increased annual investment earnings will help supplement parishioner offertory for generations to come.

Rev. Paul E. Turnbull Sacred Music Ministry Endowment



To celebrate Father Paul's 25th anniversary of his ordination to the priesthood in 1998, many of his friends contributed to create this lasting memorial. In 2017, we made available just over \$800 to support sacred music initiatives within the diocese. The Academy of Sacred Music used a grant to conduct its summer choral institute. St. John the Evangelist Parish in Altoona will apply its grant to a concert later this spring for the benefit of SS. Peter & Paul Parish in Marmont, Haiti.



Funeral Planning Workshops

We appreciate the invitation from Father Ron Osinski, pastor of Holy Rosary and Saint Mark Parishes in Altoona, to participate in the recent funeral planning workshop he hosted for parishioners of both parishes.

We shared information about (1) the Foundation's role in providing long-term support to Catholic parishes in our diocese, and (2) how to remember a parish through a Last Will, retirement IRA or life insurance beneficiary designations. Presentations from a Catholic perspective were also given by a retired estate planning attorney,



and representatives from a cemetery and funeral home. Father Ron discussed aspects of Catholic funeral liturgy planning.
