
From the President and Executive Director

Foundation Awards \$34,368 through New Impact Grant Program

The Catholic version of a "prize patrol" has been taking place in recent weeks as trustees and employees of the Independent Catholic Foundation presented checks to parishes, schools and ministries throughout the diocese. The new Impact Grant Program was funded by a generous, unrestricted bequest from a blue-collar retiree who loved his Church. After investing the funds for the last year, the Foundation's trustees decided to award a percentage of its annual earnings as grants.

The Foundation distributed Impact
Grant Applications to parishes, schools
and ministries in June with guidelines
emphasizing the grant committee's
preference to give priority to
evangelization initiatives. Funding requests

would be considered if the applications identified additional sources of income, guaranteeing that our grants would be matched. Twenty-four applications seeking a combined total of \$96,775 in need were submitted by the August deadline.

Realizing our grant pool was not sufficient enough to fund major capital renovations, the grant committee focused on supporting needs more closely linked to improving the faith lives of fellow Catholics. The Foundation awarded 22 grants totaling \$34,368. Fifty-two percent of the total amount was awarded for evangelization and youth experiences with the remainder providing support for leadership development, worship, security and renovation initiatives.

Grants to help cover expenses for the Arise Together in Christ experience were presented to St. Michael Basilica in Loretto, St. John the Evangelist and St. Therese Parishes in Altoona, St. Matthew Parish in Tyrone, Holy Family Parish in Portage, St. Clement Parish in Johnstown, St. Anthony of Padua Parish in Windber (for the benefit of all three Windber faith communities), SCI-Loretto Prison Ministry and the diocese's Evangelization Office.

Grants for student retreats were awarded to Bishop Guilfoyle and Bishop McCort Catholic High Schools, St. Joseph's Catholic Academy in Boalsburg and Divine Mercy Catholic Academy in Johnstown. Youth Ministry grants were presented to St. Augustine Parish in St. Augustine and St. Michael Parish in St. Michael, while a grant to purchase Bibles for Religious Education students went to Our Mother of Sorrows Parish in Johnstown.

Other grants included partial funding for the new organ concert series at Our Lady of Mount Carmel Parish in Altoona, a new automatic external defibrillator at Most Holy Trinity Parish in Huntingdon, upgraded security for the Altoona elementary campus of Holy Trinity Catholic School, relocation of the Saint Vincent de Paul Thrift Store in State College, a cemetery survey for Prince of Peace Parish in Northern Cambria and playground renovations at Lock Haven Catholic School.

A Foundation Impact Grant was also presented to Bishop Mark Bartchak to help cover expenses of a "Toolbox for Pastoral Management" initiative that will be presented by the National Leadership Roundtable on Church Management for the benefit of pastors later in the current fiscal year.

Board of Trustees Announces Changes



The Board of Trustees extends its deepest appreciation to Dino Persio, Esq., for fulfilling nine years of service as a volunteer trustee, and welcomes Ronald Stellabotte. Born and raised in Altoona, Stellabotte graduated from St. Francis University in 1962 with a bachelor's degree. He then graduated as a Doctor of

Dental Surgery (DDS) from the Baltimore College of Dental Surgery, University of Maryland 1966, followed by Certification in 1967. Until 1995, he practiced dentistry and lectured nationally and internationally. After retiring from dentistry, he became a financial advisor and retired from Wells Fargo Investments in 2009. Ron, who was married to Nancy for 51 years until her passing in 2015, has four children: Joseph, Jamie, Ron, and Tim. He is active in his parish, Saint Michael the Archangel in Hollidaysburg, volunteering as Extraordinary Minister of the Eucharistic and is a member of the "The God Squad" by volunteering his time and talents at FCI-Loretto, Blair County Prison and Saint Leonard's Nursing Home. The Foundation is an independent entity – legally separate from the Diocese of Altoona-Johnstown – committed to the long-term strength and viability of Catholic institutions within the eight-county diocese. The Foundation is overseen by a board of trustees comprised of lay men and women. The Diocese (as a legal entity) and the Diocesan Bishop have no role in the management of the Foundation, which is a 501(c)(3) nonprofit organization [a public charity]. Endowment funds are owned by the Foundation and can not be attached for Diocesan operating funds or any needs of the Diocese.
